  - 5/5/19 A Sermon Baltimore. Celebrating the 200th Anniversary of William Ellery Channing's "Unitarian Christianity," given in what is now the First Unitarian Church of Baltimore. Hosted the funeral of Alexander Feldvebel (Member of First Church in the 80's and 90's.)
  - Administration: UUCC Start Up Event Met with Rev. Dr. Rina Shere regarding our shared covenant and reviewed her draft covenant with the Board of Trustees Helped staff and lay leaders construct and confirm the structure of next church year's meeting and worship calendar.
